1. NEW BUSINESS

A. Closed Executive Session

In accordance with the Colorado Open Meetings Law, C.R.S. Section 24-6-402 (4), the El Paso County Emergency Services Agency, in open session, will determine whether it will hold a closed executive session. The matter for executive session will be limited to the following topics authorized under C.R.S. Section 24-6-402 (4): For a conference with the ESA attorney for the purpose of receiving legal advice on specific legal questions under C.R.S. Section 24-6-402 (4) (b); for discussion of a matter required to be kept confidential under C.R.S. Section 24-6-402 (4) (c) by the following federal or state law, rule or regulation: C.R.S. Sections 24-101-102 and 24-103-203; and for purposes of determining positions relative to matters that may be subject to negotiations, developing strategy for negotiations and/or instructing negotiators, under C.R.S. Section 24-6-402 (e). The executive session will be for the purpose of discussing competitive points for inclusion into the ambulance services RFP that will be issued shortly by the ESA, which, if disclosed during a public meeting, would impair the integrity and fairness of the RFP process. The Chair shall poll the ESA members, and upon consent of two-thirds of the members present, an executive session will be held. If consent to the executive session is not given, the item may be discussed in open session or withdrawn from consideration.
